4a (Code: ) (Expenses \$ 11,363,580 including grants of \$ ) (Revenue \$ ) With the onset of COVID19 in 2020, The Food Basket implemented its emergency food response to best meet the needs of our pandemic affected residents. Each of our programs worked to create a web of dignified food access for our food insecure residents regardless of their geography. Through these programs, we served up to 85,000 individuals per month, an increase of 6 times more than we served in 2019. Emergency food activities include, 1. Ohana Community Food Drops, over 100 large scale drive through food distributions at locations island wide, inclusive of a walk-in service area where walkers/bikers can receive food. 2. Mobile Home Delivery vans carrying prepacked food deliver to vulnerable individuals who have limited or no transportation, compromised health, and/or live in isolated rural areas.

Kupuna Pantry Program qualifying low income seniors receive a delivery of about 40 pounds of food in a drive through format island wide. 5. The Food Baskets network of more than 150 partner agencies pivoted to drive through distributions of pre packaged food and meals. 6. The Food Basket continued its SNAP Outreach to over 4,000 clients and enrolled over 220 eligible residents for SNAP benefits in 2020. 7. Our Community Supported Agriculture program DA BOX continued to incentivize healthy eating by distributing produce to nearly 300 SNAP recipients at a discount. DA BOX operates year round with weekly distribution of locally grown produce from over 75 farms serving up to 600 customers.

DA BUX Double Up Food Bucks program expanded to all counties throughout the state in 2020, with 82 retail outlets providing 50 percent discounts on Hawaii produce to SNAP recipients at grocery stores, CSAs, farmers markets and farm stands. DA BUX issued \$974K in discounts, with a total of \$1.9M in local produce sales and saw an increase of 167 percent in SNAP sales and 165 percent in SNAP customers purchasing produce at DA BUX grocers. Cumulatively, The Food Basket distributed 4.6 million pounds of food, including over \$800k of fresh produce

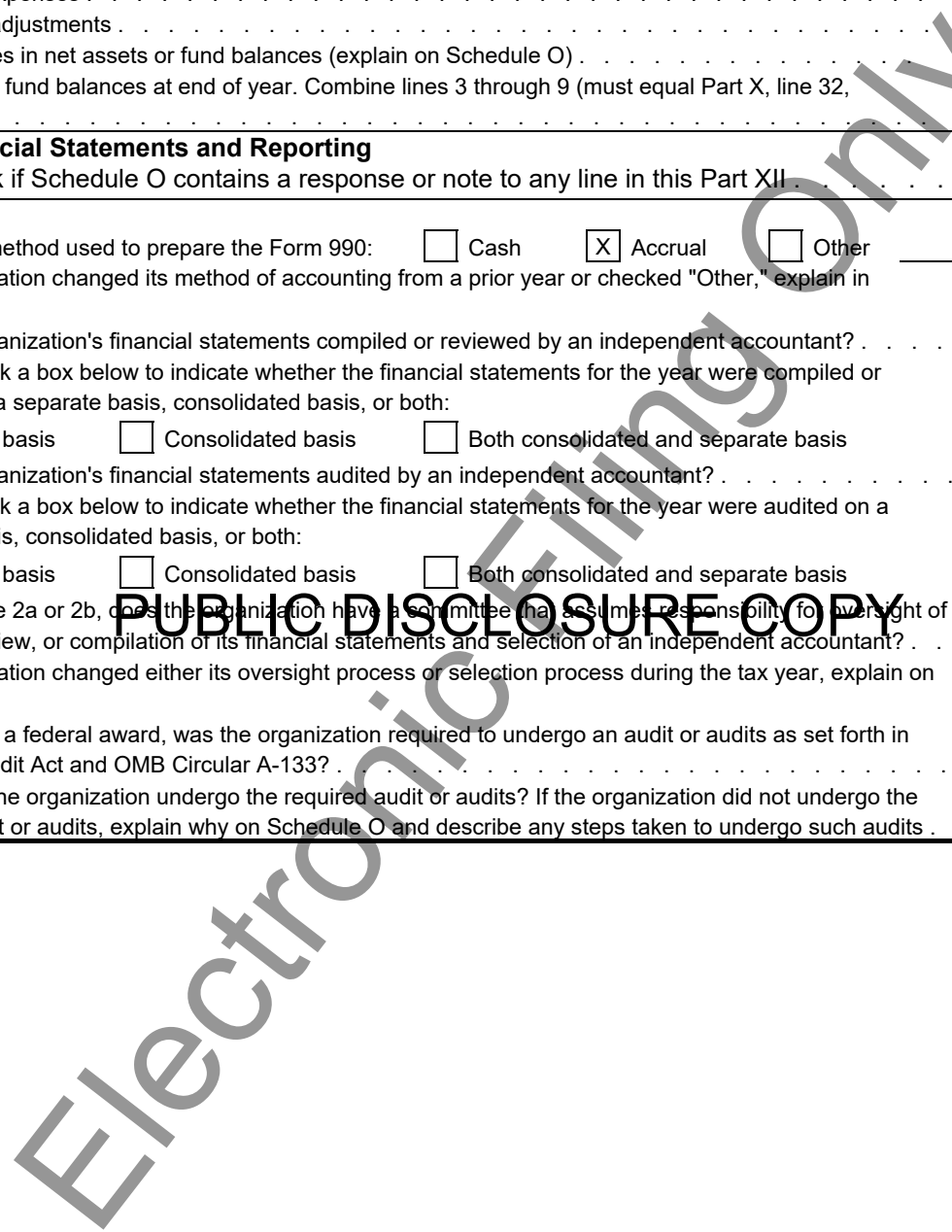
